During 2023, the National Performing Arts Funding Exchange - NPFAFE awarded more than 35 performing artists and performing arts groups financial support ranging from \$ 100 to many thousands of dollars, together with over \$100,000 in direct pro bono marketing, plus direct support to a Ukrainian refugee student of ballet. NPFAFE continued organizational and promotional support to open AAlchemy, to introduce US audiences to creative works from outside the United States
